Liz,

I hope you are doing well. I provided the attached documents containing pictures to Blake in response to Kent Lawson's concerns about the drainage ditch on his property filling up with water. However, I do not see them uploaded to the PC's share site for this coming meeting. If possible, can you please add these to the meeting share site so all involved have an understanding that this ditch has always filled with water during the rainy season. The ditch on Kent Lawson's property has never had an outlet to drain into on the south side of the neighboring property. Now that we have installed a storm drain on the south side of our property, this ditch will now likely drain into our storm drain system when it reaches the cresting height. For reference, the share site document "Att 10 Photos of Site Drainage Swale and Fence Posts at North and West Property Line" will help provide some clarity.

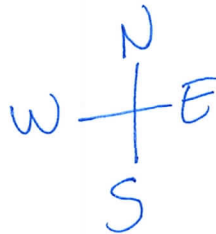
