Thank you for letting me know. I would hope that we can get on the next available meeting agenda as it has now been nearly 8 months since our permit was pulled due to an "error" made by the Planning Division of Sonoma County.

Also, please include the attached document containing pictures of chain link fences with slats that are boarding rural residential properties in the same neighborhood and streets. Both of these locations are public properties, with one of them being owned by Sonoma County (Transit Department) and the other Bellevue Union School District. In addition, I have provided a picture of the existing chain link fence topped with barbed wire on 50% of the north property line of the parking lot.

To me it would seem inequitable and unusual not to allow our Agency to install a chain link fence on our property line. The very same fence has been approved and installed for the Sonoma County property and Bellevue Union School District property. If the problem is with the vinyl slats, we will take them out. It would seem apparent that allowing the same or similar fence design we are proposing does not impact or outway the need, regardless of the rural residential areas. In fact, not allowing the fence would be out of the County's past practice and normal decision making approach.

Again, I urge you to reconsider your position on the fence location. There is plenty of evidence, past practice, and codes that allow for the fence to be placed along the north and west property lines.




