Georgia,

I am writing you about the proposed Use Permit modification to the Bricoleur Vineyards current use permit. While I believe both personally, and as a general contractor to let people do what they want with their own property for the most part, (as long as it does not negatively impact their neighbors or the community). In this case I believe that Bricoleur has already negatively affected our rural neighborhood on Starr Rd. in Windsor. If you are familiar with this area of the county, Starr Rd. is a very narrow, not even a 2 lane that is used by many joggers, cyclists, and dog walkers. Since the opening of Bricoleur to the public the traffic especially on weekends and during special events has increased dramatically. I believe that there is a serious safety concern with putting more vehicle traffic on this road. Starr Rd. is full of blind corners, dips and rises. I as someone who lives on this road (6310) and knows where to expect to come in contact with cyclists and pedestrians and drive with a speed and awareness that is needed to not kill or injure someone, can still get surprised from time to time. It has been my experience in the past couple of years that the people coming and going to this property are not aware of the dangers on this road. Especially given that most if not all will either arrive under the influence or most certainly leave the winery having drank alcohol. Adding more "party" type events is a going to further put people in danger and is not advisable.

It should also be noted where Starr Rd. intersects with Mark West Station Rd. to the south is prone to flooding, I have pulled many of people out of this area over the years. Locals understand flooded roads but those from out of the area certainly do not know when it is safe to cross and drive unaware into deep water, causing engine stalling or worse.

I do not have any objections to construction or to adding staff, I am only objecting to adding more events that would bring in more tourists or others not familiar with the road, especially when those individuals will be under the influence, it is a matter of public safety, especially to those that use Starr Rd. for recreation.

I live on Starr Road and I am writing on behalf of myself and 4 neighbors, also living on Starr Road, living within the unincorporated area of the town of Windsor and near Bricoleur Vineyards to ask that the existing use permit File No. UPE17-0053 (Bricoleur Vineyards) not be modified.

Additional traffic of both vehicles and people at the Bricoleur Vineyards is going to lead to an accident.

In addition to driving on Starr Road we all have children and grandchildren and often walk and bike as well as walk our dogs on Starr Road.

I have personally had 3 near misses, while walking, with automobiles pulling out of Bricoleur Vineyards tasting room at high speed. Neither slowing down nor looking right or left for traffic or pedestrians.

There is no sidewalk to move onto when this occurs and it has been quite terrifying.

Additionally on countless occasions when in my own car the same thing has occurred. There appears to not be any directional signs such as stop, or left or right turn only when exiting the winery. And for a vehicle traveling on Starr Road there is nowhere to go or to pull over for safety.

And while there are a myriad of lawn size signs posted pointing to the entrance to the Bricoleur Winery they are simply not enough. There is still clear confusion and slamming of brakes as cars maneuver to find the winery entrance either by coming to a full stop or performing a sharp U-turn in the road because the driver has passed the entrance.

This is also extremely dangerous particularly with the sharp blind corner on Starr Road directly across from the Bricoleur property.

Without a dedicated southbound turn lane on Starr Road into Bricoleur Winery, improved proper signage for the winery and an additional employee as a gate attendant at the gate to monitor speed in and out and an awareness of the sobriety of visitors to Bricoleur Winery this use permit should not be modified.

I (we) feel expanding the capacity of event days and increasing the capacity for food and wine pairings would be dangerous and irresponsible and increase the capacity and likelihood for a tragic incident.
