Seek tribal input regarding the identification of potential issues, possible means of addressing those issues, and appropriate actions, if any, to be taken by the County.</u></p> <p><u>(2) Assess the potential impact of proposed County actions on Tribal interests and ensure, to the maximum extent feasible, that tribal concerns are considered before such actions are taken, such that impacts are avoided, minimized, or mitigated in conformity with Coastal Act and other applicable legal requirements.</u></p> <p><u>6. Provide Tribes with meaningful opportunities to respond and participate in decision-making processes that affect Tribal Interests.</u></p> <p><u>8.
