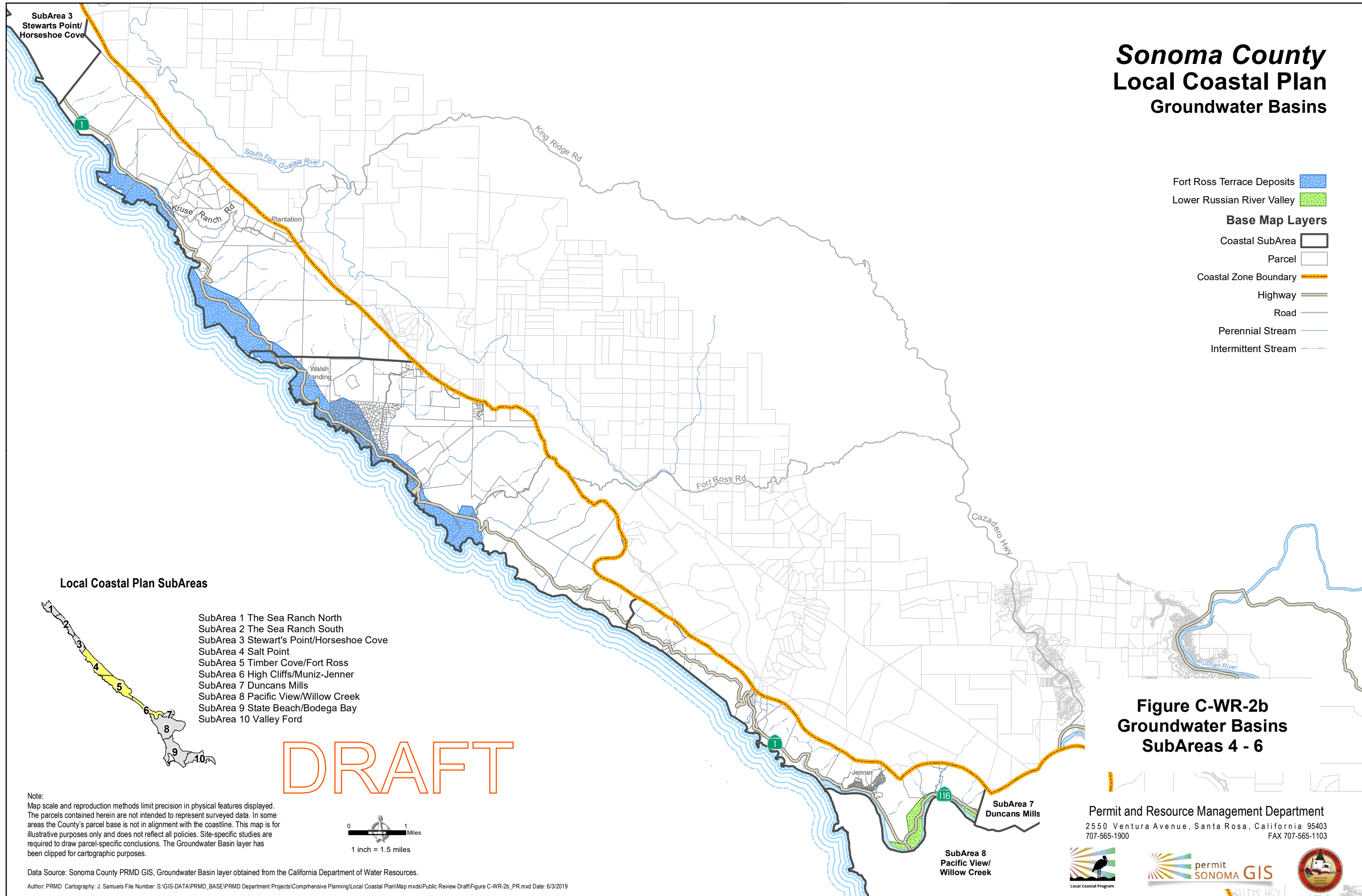

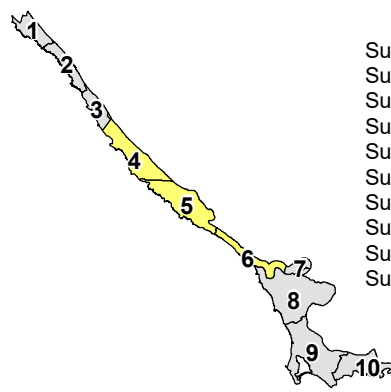

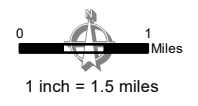

SubAreas 4 - 6**









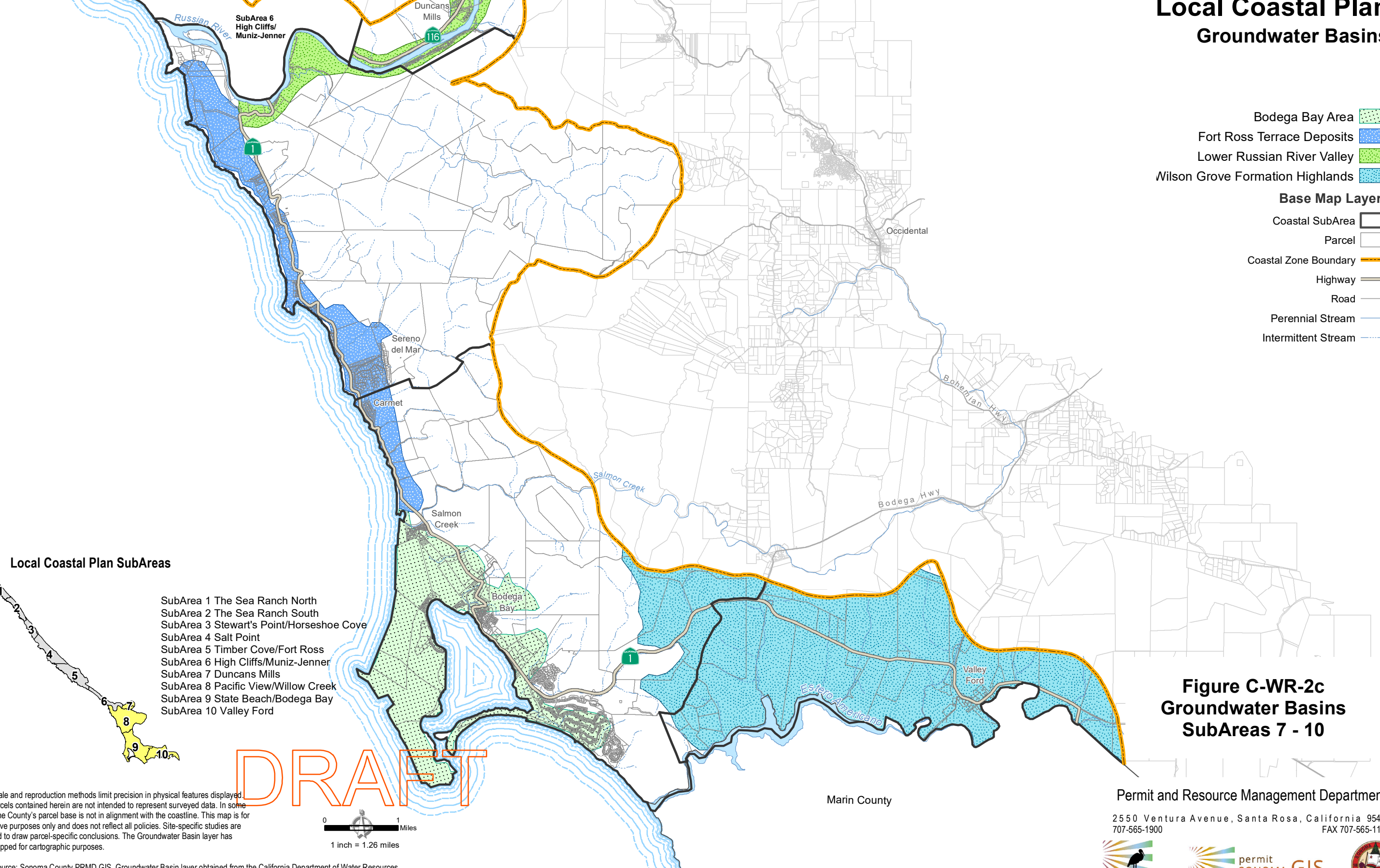

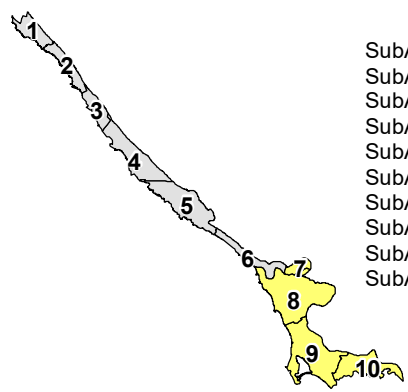
