The Ordinance update team is working on developing the draft ordinance framework right now (highlighted in yellow below), based on the public outreach already conducted earlier this year and Board direction given on 9/28/2021. Part of the current effort is identifying specific elements of that framework where additional public outreach could help inform development of the actual draft ordinance during the **Development and Refinement of Draft Ordinance** phase, which is targeted to begin early next year. Hi Nancy and Brantly,

It has been a little while since we've communicated so this might be a bit lengthy.

First, to answer your question if we are discarding comment: No.

Was the public comment only used to develop the item for 9/28: No.

We do not list environmental requirements as policy options because they are not options, <u>they are</u> <u>mandatory</u>. Even if no one cared about water we would be looking at impacts to water resources (Hydrology/Water Quality), for example.

Right now we are taking the feedback already received over the last few months, particularly at the September BOS meeting, and developing what we are calling the ordinance framework. Most of that comment was not new—you all, and others, have been very consistent in your message. We're still hoping to have the next deliverable for the public completed internally in December so that we can come to the BOS and public in late January and get feedback on that and hopefully get the green light for a Request for Proposals (RFP). The RFP process is how we begin the process of selecting a firm to conduct the EIR on the project.

While that RFP is occurring, which likely will take 6 months, we'll use that time to begin developing the draft ordinance content itself and coming back out to the public again. I'm hoping to go beyond small group zooms and surveys but we'll see what early 2022 has in store for us. To begin the RFP process we need what is essentially a list of expectations on what will be looked at, so that environmental firms can determine whether they have the qualifications and resources (time) to meet the needs of the project. Once the RFP process is complete we will then have the more refined project description to hand over to the environmental firm.

Sharing the draft ordinance framework, getting authorization to put out an RFP, and awarding the contract are all part of the public process.

One of the less exciting pieces that we've been working on since September is the admin side of things. Since this is a multi-year effort that involves new term-limited positions we have been working with Human Resources, conducting interviews, reviewing potential budgets, making sure we have outreach capacity with existing communications folks, and figuring out where our new planner and admin assistant are actually going to sit (once they are hired).

I hope you have a wonderful Thanksgiving, thank you for giving me the opportunity to share a bit about what we have been working on!

We recently reviewed the material presented to the BOS on 9/28 and see that this period of time (October through December of 2021) is to include "Continued public engagement" as you "develop complete framework". Also "Continued public engagement" is listed to occur from January to May of 2022 after the "complete draft ordinance/EIR project description" has been released.

Questions: What exactly is being done to invite further public engagement? Will all the input the public has already provided in the workshops, small group sessions and survey be considered as you "develop the framework"? or has that been discarded and does the public have to resubmit? Was that input from the public only used to develop Staff recommendations (page 22) for the 9/28 hearing? In other words, are you only using page 22 to develop the framework? Did you notice that water resources is not on that list? There are many more CEQA requirements that do not appear on the list of staff recommended "policy options". Copied below. Will they be addressed in the "complete draft ordinance/EIR project description? Will the "complete draft ordinance/EIR project description" be released in early or late January?
