**CommissionerTamura**, commented that the maps provided were not sufficient for terms that it was unsurmountable for alternative site. They did not meet the burden to show a less impactful site that could be used. 2h42m

**Commissioner Koenigshofer** from staff report on page 6, SR section sited HWY 101 is in a Scenic Corridor, within a Scenic Landscape Unit. Requirements for visual analysis purpose to focus on scenic resources and the Scenic Landscape site make it inconsistent to the General Plan. Urban growth boundaries would also be impacted. County Policy encourages collation but does not require it. 2h43m
